And whereas it is necessary to declare the aims and objects of the public charitable public trust, being constituted under the these presents.

Now this indenture witnessed as follows :-

1. Para Medical College, Engineering College, Pharmacy College, Dental College, Liboraties, Skill development centre, competition: Preparation centres, Yoga and spiritual centres, sports training centres, vocational and Technical training centres research and other institutions for the development and advancement of education and diffusion of know ledge among the public in general.
- (b) To establish, maintain and run studentship, scholarship and award programme and render other kind of aid to students including supply of study materials.

All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its Aims and no objects only as set forth in the deed of the Trust and no profit there of shall be paid or transferred directly by way of divides, bonous, profits or in any manner whatsoever to the present or the past memeber of the Trust or to any person cleaning through any one more of the present or the past members. No members of tec Trust shall have any personal claim on any movable or immovable properties fo the Trust or make any profits, whatsoever, virtue of his membership. 5. That the Trust Fund may be augmented by the income from the initial fund also by donations and other contributions from time to time.
8. That the Trust fund shall not be applied for any purpose other than those specified in Para-3 herein above unless the other objects added to the trust objectives.
9. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the Trust.
10. 19. It is expressly declared that no part of the Trust property or its income or any accretion there to shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law and all provision here of shall be construed accordingly.

POWER AND DUTIES OF THE CHAIRMAN :-

- (i) The chairman shall preside over the meeting of the trust and other constituent units.
- (ii) The chairman shall be empowered to appoint any staff lawyer, Doctor and teachers, etc and fix his salary of remuneration.
- (iii) The Chairman shall be the executive of factor of trust and shall executive supervisory power over all the institutions as and when necessary for discharging his duties.
